The quotations will be opened on dated 14/05/2026 at 11 AM in the office of Director Principal Govt Medical College Patiala. In case holiday is declared on the date of opening quotations, it will be opened on the next working day at the same time.

The terms and conditions of the supply are: -

- 1) Bidders will have to quote the amount for one Domestic R.O in the quotation the actual quantity will be mentioned in the supply orders after obtaining the actual demand from the different Hostels and Heads of the Department.
- 2) Inquiry/NIQ No. Must invariably be given at the top of the envelopes. Envelopes without indication will not be entertained.
- 3) Tax will be paid extra, if applicable provided it is made clear in the quotations that G.S.T@ % will be charged extra, otherwise it will be presumed that G.S.T are not to be paid extra.
- 4) Unsealed quotations will be rejected.
- 5) Validity of the quotation should be for a minimum period of 120 days.
- 6) The quotation must be addressed to the Director Principal Govt. Medical College Patiala.
- 7) Service will have to provide immediately.
- 8) The Institute reserve the right to reject the CMC contract if the service is not found in accordance with the PO.
- 9) Quotations must be sent by registered post/Speed Post/ Courier/by hand at receipt Branch of Govt. Medical College Patiala within working hours (9 am to 5 pm).
- 10) C.M.C Rate will be fixed for one year from the date of PO.
- 11) Service provide will have to keep working all R.Os during C. MC period.
- 12) No Extra payment/items and man power will be given/provided by this institution to service provider.
- 13) The firm Shall depute technically qualified and experienced staff to carry the repair and maintenance of R.Os during C.M.C Period.
- 14) 50% Payment of Maintenance contract will be released after every six months on the basis of satisfactory working report of R.Os from concern Hostels I/Cs, Heads of the Department.
- 15) Firm will have to provide 4 Services during the CMC Period.
- 16) Replacement of the Pre-filter candle/filters ( Post silver Carbon and Membrane) will ne made twice in contract period.
- 17) The prospective bidders are advised to visit the site before submitting their bids for checking the brands of Domestic R.O
- 18) The Bidder must have GST registration as per GST Act and rules, also have to mention G.S.T number on the quotation.
- 19) **Before submitting quotation by the Bidder, it shall be mandatory to clearly mention GST number of the firms /company in the quotation. If not, quotation will not be considered.**
- 20) Bidder must mention the contract number of the firm on the quotation.
- 21) All Participant bidder advised to attend the opening of quotation on the due date.
- 22) The bidder within 15 days after receipt of the acceptance letter shall be required to pay Performance Security Deposit in the shape of **Bank Guarantee of 5%** of the total value of the supply order without taxes as performance security. The Performance Security shall be denominated in Indian Rupees an unconditional Bank Guarantee issued by a Nationalized/Scheduled Bank located in India This performance security amount will be refunded after satisfactory completion of CMC period.
